

## How to Revoke a Financial Power of Attorney



### Can I revoke my Financial Power of Attorney?

Because a Financial Power of Attorney was given voluntarily by you to another person, you have the right to revoke it at any time so long as you are legally competent.



### How can I revoke my Financial Power of Attorney?

The best way to revoke a Financial Power of Attorney is to make a written statement revoking the document. A fill-in-the-blank form is included on the next page.

Then, you should give it to everyone who has a copy of the revoked Financial Power of Attorney. Then, you should destroy any copy of the revoked Financial Power of Attorney.

If your Financial Power of Attorney was recorded in the office of the county recorder, then your revocation is not effective until it is also recorded in the same office.

Please keep in mind that adding a new Statutory Form Power of Attorney will not revoke any prior one you signed.
